MINIMUM ELIGIBILITY CRITERIA*:

1. Minimum CPI - 5.5 or more up to semester 4 (summer exam 2024).
2. Maximum backlog – 3 up to semester 4 (summer exam 2024).
3. Semester - Students who will complete the exam of **SEMESTER 6** in summer 2025.

NOTE: CPI & backlogs of only regular semester IV exam (summer exam 2024) shall be considered for the eligibility. The updates in the results of semester IV after remedial exam of Winter 2024 shall not be considered for the eligibility criteria.

*Final Selection shall be done purely on merit basis w.r.t the number of available seats

TENTATIVE DURATION OF IEP - 2025:

- 1st/2nd Week of July 2025 – 2nd week of August 2025 (Approximate Days-35) (Immediately after completion of end semester exam of semester – 6 in summer 2025)
- Selected student will travel to Poland Immediately after the completion of end semester exam of semester – 6 in summer 2025.
- The duration and number of days may vary in case of any unexpected situation/factors impact the program adversely.
